#### **RULES and REGULATIONS**

- 3. **MEMBERS:** respect all members and their individual plots and space.
- 4. **MEMBERS TENANCY AGREEMENTS:** These help to clarify and set out the guidelines to maintain the rights of individual members. Should questions or queries arise, then these should be the first point of reference.
- 5. MANAGEMENT COMMITTEE: The Committee is an elected body set up to manage the allotment site with the express intention to enhance the future and continued success of the allotments and the OAA, for the benefit of its members and local residents. Decisions will be taken by vote with every member eligible to participate, the Committee serves to enact these decisions. The Committee will make themselves available and accessible to support members with any queries, requests or concerns via email, telephone, or WhatsApp (see contact adjoined sheet for details).
- 6. **MEETINGS:** The Committee will meet at least four times per year. Members will be invited to attend a meeting (by Zoom, on the site, or potentially the Village Hall or the Green Man) on a regular basis as matters arise.
- 7. **INTERNET and CONTACT**: Committee members will be available on the group email address: <a href="mailto:OAA.Committee@gmail.com">OAA.Committee@gmail.com</a> or via their personal contact details and preferred means of communication as set out in the Association's contact list. This list will be kept up-to-date by the Committee Secretary.
- 8. **GRIEVANCES**: Members can raise a grievance by contacting the Committee Chair. All issues will be managed with discretion and actions agreed with the complainant. If the complaint involves the Chair, members can raise an issue with any other Committee member.
- 9. EQUALITY, DIVERSITY, INCLUSIVITY: all allotment applicants and Association members will be treated equally and without discrimination based on any protected characteristics (age, disability, gender reassignment, marriage and civil partnership, pregnancy and maternity, race, religion or belief, sex, sexual orientation). Any reports of discriminatory or offensive behaviour will be taken very seriously and acted upon please read our Equality and Diversity Policy for more details.
- 10. INSURANCE: Indemnities.
